

Mint UK combines information from 11 specialist sources and allows you access to over 5 million UK companies (including unincorporated businesses). The information is presented in a variety of formats and allows you to:



- Search for companies, news articles, directors and industry profiles matching specific criteria.
- ▶ View the corporate group, credit scores, brand names and activity descriptions.
- ▶ View results in flexible and fully customisable lists to create highly targeted mailing lists
- ▶ Access articles taken from various providers including the FT news sources.
- Search information on both current and previous directors of UK businesses. Provides address, date of birth, nationality and biographical information for directors of listed companies.
- ► Access Market Research reports with global coverage provided by MarketLine and Morningstar.
- Create impressive graphs to illustrate your results for use in reports or presentations

The Mint UK database offers an alert system meaning that you can monitor companies and receive emails when

- ► Their report is updated
- Directors change
- ▶ They appear in news articles



#### How do I Access it?

You can access Mint UK by coming into any Glasgow Library or the Business @ The Mitchell department of the Mitchell Library with your Glasgow Library card.

All information is free to view however there is a charge for downloading or printing. Downloading and printing is only available at the Mitchell Library. Help in constructing searches and downloading information is always available from Business @ The Mitchell.

# What criteria should I use when compiling my list?

- Trade description
- Location
- ▶ Turnover
- Number of employees
- Incorporation date
- Director information
- Foreign companies
- Banker

## How should I format my list to achieve its full potential?

- Standard List (Name/Full r/o postcode/Registered number/Primary SIC code/Latest accounts date/Latest turnover last available year /Latest number of employees)
- Credit List (Name/Current QUI Score/Ultimate Holding Name/Current ratio /Gearing Ratio % /Debtor collection days /Turnover /Profit (Loss) before tax )
- ► Financial List (Name/Turnover + prev 2 yrs/Profit (Loss) before tax + prev 2 yrs/Total assets + prev 2 yrs/Number of employees + prev 2 yrs)
- Audit List (Name/Auditor/Audit Fee /Non-audit Fee /Turnover / Profit (Loss) before tax )
- Modify any existing list format
- Create an entirely new list format
