- Falling levels of attendance
- Equipment out of service contract and passed repair
- Equipment lease has or near expiry
- Investment Cost of new bikes alone would be approx. £25K investment. In current financial climate this is not a viable or recommended option.
- Industry standard is to have "fit for purpose" dedicated group cycle space and not shared room space
- More effective use of the bikes (storage of bikes in cupboard is no longer a reasonable option due to damage to bikes and consoles)
