Cash Transactions – reintroduction of cash transactions at 15 Glasgow Club venues: Bellahouston, Pollock, Kelvinhall. Drumchapel Pool, Maryhill, Gorbals, Castlemilk Pool, Castlemilk Sports Centre, Springburn, North Woodside, Whitehill Pool, Emirates Arena, Scotstoun Campus, Tollcross, Crownpoint, The Bridge.

b) Reason for Change in Policy or Policy Development

Pre booking of activities/cashless payment has been the means of booking at all of the above venues since re-opening has afforded during the COVID-19 pandemic. Guidance has been to not re-introduce cash to reduce contact of 'paper' between customers and staff members. It also reduces the need for cash uplift by external parties ie G4S. It is however recognised, that pre-covid cash transactions were greatly used by Glasgow Sport Customers; an example of which is Springburn Leisure Centre recorded up to 60% cash sales pre-covid versus cashless sales. Whilst we are moving towards a cashless society, it is apparent that certain sections of Glasgow's population may not be able to participate in activities until 'cash' is offered as a way to book and pay for activities.

c) List main outcome focus and supporting activities of the Policy, Project, Service Reform or Budget Option

As we move into 'Beyond Level 0' it is apparent that cash as a means of payment continues to be used in many businesses, whether that be in hospitality, grocery stores, supermarkets etc. Glasgow Sport needs to be able to offer this service for the customers highlighted above (ie 60% pre-covid payments taken in cash at Springburn Leisure Centre).



Cash has always provided a means of payment for a broad spectrum of Glasgow Club users – whilst the emphasis in business (accelerated by the coronavirus pandemic) is driven by the aspiration for the economy to move to a 'cashless society', many Glasgow Club customers are still reliant on cash. An example: Pre-Covid cash sales in the North East of the City (one of the most deprived areas of the city), were sitting as high as 60% of total sales. Due to the demographic of the North East of the city a large portion of customers do not have access to debit cards which will prevent them from using facilities. The re-introduction of cash transactions will mitigate the current imbalance in booking available. Contact tracing protocols will remain in place and customers and user groups (the lead member) will be required to collect and/or provide contact data in accordance

Summary of Protected Characteristics Most Impacted

Affects all protected-characteristic groups. The re-introduction of cash payments will afford many customers without the ability to use cashless payment means access to pay for Glasgow Life services.

All Protected Characteristic groups may be impacted at the venues of: Littlehill Golf Course, the football venues at Glasgow Green and Toryglen Football centre. This is due to these venues remaining cashless payment only.

Summary of Socio Economic Impacts

Pre-covid, cash was greatly used in many area of the city, in particular by those who do not have access to credit or bank cards. By offering cash payments, customers that have been negatively impacted by cashless sales, will be offered a way to return to venues.
