

Understanding Your Payslip

The following diagram explains key parts of your payslip. Please note that the diagram shows an entirely made-up payslip and does not reflect the circumstances of a real person. However, the layout and terminology will be similar to your own.

Your current tax code, e.g 1060L which determines the amount of tax you pay. For example in this case the employee would be entitled to earn £10,609 before paying tax

This is your SAP number: An 8 digit number unique to each employee. This number should always be quoted when contacting HR or CBS. If you have more than one job there will be a separate unique 8 digit number for each job.

This number is also known as PAYE reference and should be quoted when corresponding with HMRC

Date Payment is credited to your bank account

Core pay is your basic contractual pay and excludes non-core pay, overtime, etc

NSWP stands for Non-Standard Working Pattern/Hours, also known as Non core pay, and takes into account weekend working, shifts, standby etc.

WCD is the Working Context and Demand payment, a non-core payment for working in difficult or distressing situations.

Additional hours that have been worked in this period

Holiday pay for additional hours that have been worked in this period

The number of additional hours that have been paid.

The rate paid for the hour

This is your pension contribution for this period. Pension is amount deducted before tax. Percentage is determined on Annual Salary as at 31st March.

This is your gross pay (pay before tax)

Net pay is your total allowances minus total deductions.
