## Request under the Freedom of Information (Scotland) Act 2002 ("The Act")

Thank you for your correspondence of 8 November 2021 where you asked for information relating to tennis facilities. For reference, the full details of your request are set out in the Annex to this letter.

Culture & Sport Glasgow (trading as Glasgow Life) is treating your request as a request for information under the Freedom of Information (Scotland) Act 2002.

Glasgow Life's response to each of your questions are set out in the Annex to this letter. The Annex also explains why some of the requested information has not been provided to you.

## **Right of Review**

If you are dissatisfied with the way Glasgow Life has dealt with your request you are entitled to require Glasgow Life to review its decision. Please note that for a review to take place you must:

Glasgow Life's response to your information request is noted below (numbered for ease of reference).

1. How many public (council run) tennis courts are there in your local authority?

Glasgow Life can respond as follows:

Scotstoun- 8 x Indoor Courts
Gorbals- 4 x Indoor Courts
Queens Park - 5 x courts - Synthetic
Knightswood - 4 x courts - Tarmac
Drumchapel - 3 x courts - Tarmac
Kelvingrove - 6 x courts - Synthetic
Victoria Park - 4 x courts - Tarmac
Scotstoun - 3 x courts - Carpet
Maryhill - 4 x Courts (2 in use) - Red Blaes

# 2. How many public (council run) tennis courts were there in your local authority in 2011?

Please refer to our response at question 1 above.

3. How much public money from your local authority was spent on the upkeep of public tennis courts in the financial year 2020/2021?

We can confirm that £16,250 was spent on Kelvingrove tennis court and Queens Park tennis court. There is no defined required maintenance on the other courts that need an expenditure.

4. How much public money from your local authority was spent on the upkeep of public tennis courts in the financial year 2010/2011?

On inspecting our records, it would appear that Glasgow Life does not hold some of the information which you have requested. Neither does anyone else hold it on our behalf. Accordingly we are unable to comply with this aspect of your request in terms of section 17(1)(b) of the Act. By way of explanation, records are no longer available for this period.
